With my individual responsibility and knowing the sanctions (3) provided by the provisions of paragraph 6 of Article 22 of Law 1599/1986, I declare that:

1. I am obliged to care for the animal in accordance with animal welfare legislation and provisions. Δεν επιτρέπεται να έχω το ζώο σε κλουβί ή να το έχω συνέχεια δεμένο.
2. The animal is not to stay alone on balconies and terraces without shade and water, or without supervision when the owner is away.
3. The "use" of the animal for hunting, for breeding or for other professional purposes is prohibited.
4. The animal must have sufficient space in its living situation.
5. If the animal is not neutered/spayed, I am to neuter/spay the animal. Neutered/spayed dogs are happier and lives longer as they will not suffer from continuous births, womb cancer, they do not create packs, and they do not have the tendency to escape and risk their lives by getting hit by a car. The neutered/spayed animal will not get fat if they are properly fed and get adequate exercise, and their character is not altered. They do become less nervous and are more obedient.
6. Once a year I am obliged to visit the vet with my dog for vaccination and general blood tests. If the animal seems sick, I have to visit the vet earlier.
7. The members of the Syros Stray Animal Shelter/Φ.Ο.Σ. are not responsible for any illnesses that may occur after receiving the animal from the sponsor / owner, however, they should be informed.
8. I must inform the Syros Stray Animal Shelter/Φ.Ο.Σ. immediately in the event of death, disappearance or accident of the animal.
9. The delivery of the animal to other persons is permitted only upon written approval from the Syros Stray Animal Shelter/Φ.Ο.Σ.
10. Only veterinarians have the right to decide to put down the animal **and only after informing our the Syros Stray Animal Shelter/Φ.Ο.Σ..**
11. I agree to any occasional check ups on the animal by the Syros Stray Animal Shelter/Φ.Ο.Σ..
12. For any failure to follow all of the above, the Syros Stray Animal Shelter/Φ.Ο.Σ. has the right to request the return of the animal.
